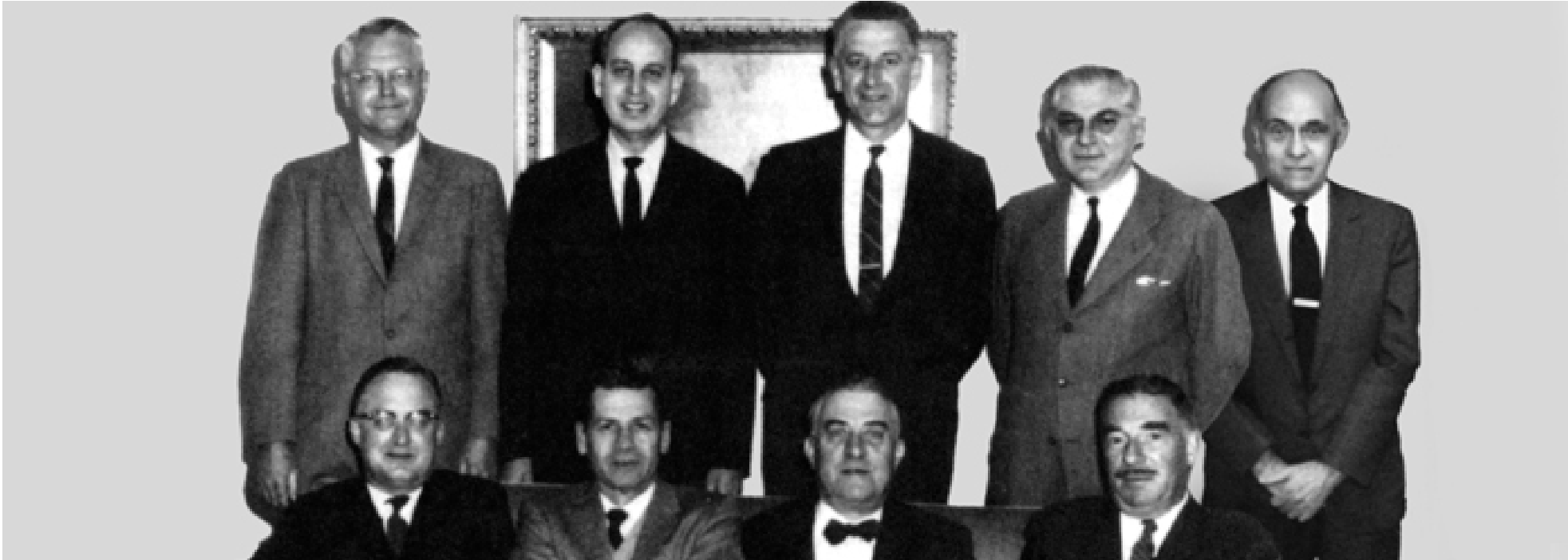


Society of Toxicology Founded 1961

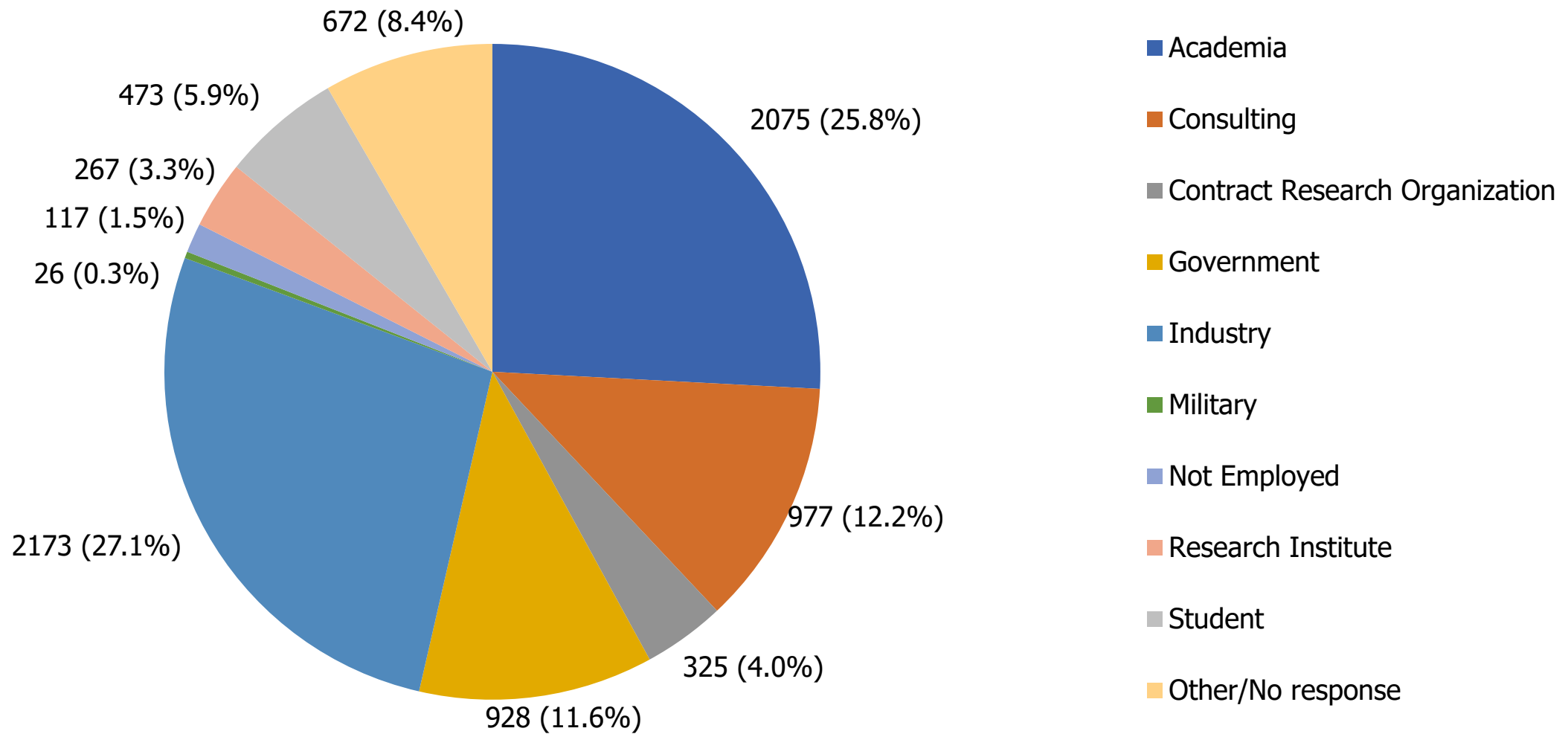
